

TERMS AND CONDITIONS FOR DISPOSAL OF CONDEMNED UNSERVICEABLE STORE ARTICLES / SCRAP ARTICLES/ ELECTRONIC/COMPUTER DEVICES IN THE OPEN AUCTION HELD ON 22-11-2022.

1. The Directorate of Prosecution, SDA Complex Block No -22, Kasumpti, Shimla-9 intends to dispose of unserviceable store articles / scrap articles/ electronic/computer devices of the Directorate of Prosecution, H.P., on **“as is where is basis”**.
2. The disposal of uunserviceable store articles / scrap articles/ electronic/ computer devices of the Directorate of Prosecution, H.P, vehicle shall be strictly on **“AS IS WHERE IS BASIS”** and no guarantee or certificate of its worthiness or quality will be given by the Department. The condition of the articles can be inspected physically by the interested bidder at Office of Directorate of Prosecution, SDA Complex Block No -22, Kasumpti, Shimla-9 up to 21st November, 2022 on any working day during office hours.
3. Each bidder will have to deposit Rs 5000/- as earnest money for participating in the open auction. This amount will be adjusted towards the sale amount of money in case of successful bidder.
