TERMS AND CONDITIONS FOR DISPOSAL OF CONDEMNED VEHICLE NO HP 63-A-
2621 IN THE OPEN AUCTION HELD ON 10-10-2022.

1. The Directorate of Prosecution, SDA Complex Block No -22, Kasumpti, Shimla-9 intends to dispose of condemned vehicle, on "as is where is basis".
2. The disposal of vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the Department. The condition of the vehicle can be inspected physically between may be inspected by the interested bidder at Outside Office of Directorate of Prosecution, SDA Complex Block No -22, Kasumpti, Shimla-9 from 20-11-2022 to 04-12-2022 on any working day during office hours.
3. Each bidder will have to deposit Rs 5000/- as earnest money for participating in the open auction. This amount will be adjusted towards the sale amount of money in case of successful bidder. And in case of other, the earnest money will be refunded. If the highest bidder / successful bidder fails to deposit the sale price within 01 day time positively, his earnest money will be forfeited.
