ORDER

The Hon'ble H.P. State Administrative Tribunal while disposing of O.A. No.2701 of 2018 titled Suresh Kumar Vs. State of Himachal Pradesh and others on 17-05-2018 passed the following order.

"In the facts and circumstances of the case, the original application is disposed of with a direction that the applicant may file a comprehensive representation for cancellation of his transfer or suitable adjustment alongwith certified copy of this order to 2nd respondent within five days. 2nd respondent shall decide the same after affording an opportunity of being heard to the applicant as well as private respondent no.4, if so desired, by 29th May, 2018."


In compliance to the above order of the Hon'ble Tribunal, the applicant, Suresh Kumar was heard in person on 29.05.2018 and during the hearing he stated that as he has already served in the tribal area which is one of the mandatory condition as laid down in the Comprehensive Guiding Principles-2013 and a period of less than 2 years have been left for his superannuation. Therefore, as per the above principle, either, his transfer to the Child Development Project Office, Rewalsar be cancelled or he may be adjusted in the Child Development Project Office, Bijhari against the longer stay of the incumbent there. The Applicant has

further requested that keeping in view his family circumstances, health problems and tenure of less than 2 years for superannuation, he may be adjusted in the office of Child Development Project, Bijhari against the incumbent posted in the office of the Child Development Project Officer, Bijhari.

Therefore, in view of the request of the applicant as he has already served in the tribal area and only period of less than 2 years have left for his superannuation. Therefore, the applicant, Sh. Suresh Kumar who has completed normal tenure of three years in his present place of posting in ICDS Project, Hamirpur and who is under transfer to Child Development Project Office, Rewalsar is now adjusted in office of the Child Development Project, Bijhari and Sh. Girdhari Lal who is posted as a Driver in ICDS Project, Bijhari, Distt. Hamirpur since 23.12.2002, is now transferred to ICDS Project, Rewalsar, Distt. Mandi under Clause 5(5) of the Guiding Principle ibid.
