Subject : **Registration for IPR Online Advertisement Management Software (OAMS) for Publication of Advertisements (Classified & Display).**


Sir/Madam,

The department of Information & Public Relation is switching over to **Online Advertisement Management Software (OAMS)** for publication of Classified & Display advertisements in Print Media from 1st May, 2017. The department is in the process of registration of all the stakeholders including Newspapers and Govt. offices for issuing all types of advertisements. IPR Online Advertisement Management Software is a fully automated web portal, once registered with OAMS, it would enable all the offices of all the departments/boards & corporations of Himachal Pradesh, to upload their advertisement (classified & display) proposals for publication in newspapers.

Through this OAMS, the departmental proposals (requests for publication of tenders/notices, display advertisements etc.), so received, would be further released online to the newspapers for publication by the IPR department. The issuing offices will be getting instant information about the current status of their advertisement proposals at each step including the names of newspapers, their date of publication etc. The proposals with short notice period will be intimated to the departments through the web portal so that the dates could be rectified accordingly. **The OAMS is aimed at bringing more transparency and efficiency in release of advertisements besides providing updated information of the advertisements to all the stakeholders as the issuing offices would be able to view, search and keep record of advertisements like tenders/notifications/public notices and display advertisements etc.**


You are, therefore, requested to direct all the offices under your control to register as user on the IPR Online Advertisement Management Software through iproams.himachalpr.gov.in by clicking on the link 'Register as New user' up to 30th April, 2017. An online form will appear on the screen. Please fill the form as per the directions given in the form. After submitting the online registration form, user will receive a message on the registered e-mail account followed by a verification message from IPR department. User will also receive a link to reset the password to access OAMS account. User can use this link to change the password, if required. **All the stakeholders are requested to strictly adhere to the last date of registration i.e. 30th April, 2017, since no offline advertisement proposal will be accepted after 1st May, 2017 by the department.**
