OFFICE ORDER

On the recommendation of the Departmental Screening Committee to assess the suitability of the candidates for regularization of Contractual appointees and consequent upon the completion of three years service as Supervisor on Contractual basis on **30.09.2021** in pursuance of Department of Personnel, Government of H.P letter No. PER (AP)-C-B-(2)-1/2019, dated: 30.03.2021, the following Supervisors appointed on contract basis are hereby regularized and offered a temporary post of Supervisor in the **Pay Band of Rs. 10300-34800+3200 (Grade Pay) at the minimum of the time scale of the post** and posted in Supervisor Circles shown against their names. They will also be entitled to draw dearness and other allowances at the rates admissible and subject to the conditions laid down in rules orders governing the grant of such allowances in force from time to time:-

2. The terms and conditions for this appointment/ regularization are as under:-

- i) The appointment is temporary and will not confer any title of permanent employment.
- ii) The services of the appointee may be terminated at any time by a months notice given by either side viz, the appointee or the appointing authority without assigning any reasons. The appointing authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice or the unexpired period thereof.
- iii) The appointment carries with it the liability to serve in any part of Himachal Pradesh, and will have to serve in Tribal/ Difficult area.
- iv) Other conditions of services will be governed by relevant rules and orders in force from time to time.
- v) The seniority and other benefits would be applicable from the date of joining on this post.
- vi) The contractual appointees to be regularized shall be appointed at the minimum of the time scale of the post.
- vii) The Contractual appointees who are regularized shall be liable to be posted anywhere within the state.
- viii) The regularization will be with prospective effect i.e. from the date of issue of regularization orders.

3. The appointment will be further subject to the production of :-
- i) Certificate of fitness from Chief Medical Officer/ Civil Surgeon in original in accordance with the provisions contained in FR 10 and SR 4(1), 4(2) and 4 (3).
 - ii) Attested copy of Educational Qualification Certificate/Degree from the recognized University and copy of Matriculation Certificate as proof of date of birth and bonafide Himachali Certificate.
 - iii) Copy of SC/ ST & OBC Certificate, if any.
 - iv) Submission of a declaration to the effect that he has not more than one living wife in case of person who is married.
 - v) Taking of an oath of Allegiance/ faithfulness to the Constitution of India (or making solemn to that effect) his character and antecedents are found satisfactory.
 - vi) He/She will be on probation for a period of 02 years from the date of joining the post.
 - vii) Verification of her/his character and antecedents as provided in H.P Financial Rules.
4. If any declaration given or information furnished by the above mentioned Supervisors proves to be false or if she/he is found to have willfully suppressed material information, he/she will be liable for removal from service and to such other action as Government may deem fit and necessary.
5. If the above mentioned Supervisors accept the offer on the terms and conditions mentioned above, they shall report for duty in the concerned offices of the Child Development Project Officers **on or before 20.11.2021**, otherwise this offer shall stand cancelled.
