Terms & conditions of appointment:-

This offer for appointment on contract basis is subject to the verification of the genuineness of their Graduation Degrees from the concerned university. If any later stage, the said Degree of the candidate is found invalid or not genuine after getting verification, this offer will stand cancelled.

This contract appointment will be initially for one year which may be extendable on year to year basis depending upon the performance and work and conduct on the job:-

- 1.
