Office Memorandum

Whereas, Final Seniority List of Matriculate and above qualified Anganwadi Workers having 20 years experience as on 31-03-2021 was issued to all the District Programme Officers(ICDS), vide this office letter No.WCD-A-B(1)246/2016-Estt. (Seniority M-AWWs)-20554-565 dated 24th March, 2022 for further circulation to Anganwadi Workers through Child Development Project Officers and Fourteen objections were received from AWWs through DPOs/CDPOs even after issuing the said final seniority list.

And whereas in compliance to order passed by the Hon'ble Himachal Pradesh High Court on 25th July, 2022 in CWP No. 3978/2022 titled as Medo Kumari V/s State of Himachal Pradesh & Others and after rectification of the above 14 objections caused by clerical mistakes in the information of Anganwadi Workers submitted by the DPOs, Revised Final Seniority List of Matriculate and above qualified Anganwadi Workers having 20 years experience as on 31-03-2021 was circulated vide Office Memorandum No.WCD-A-B(1)246/2016-Estt. (Seniority M-AWWs)-6552-6574 dated 27th August, 2022 as well as uploaded on the website of Directorate of Women and Child Development, Himachal Pradesh for calling objections from the AWWs if any.

Moreover, 99 objections of grave nature and 103 objections of minor nature were received from AWWs through DPOs/CDPOs. Due to incorporation of these objections of Anganwadi workers in the Revised Final Seniority List, seniority number of most of the other Anganwadi workers was again changed. Therefore, Provisional Revised Final seniority List of Matriculate and above qualified Anganwadi Workers having 20 years experience as on 31-03-2021 was circulated vide this office Memorandum No. WCD-A-B(1)246/2016-Estt. (Seniority M-AWWs)-4371-4448 dated 09-11-2022 for calling objections again from the AWWs

Whereas, following 185 objections of grave nature and 427 objections of minor nature have been received from AWWs through DPOs/CDPOs, which have been incorporated in the Provisional Revised Final Seniority List and Final Revised Final Seniority list of Matriculate and above qualified Anganwadi Workers having 20 years experience as on 31-03-2021 has been prepared and enclosed herewith as well as has been uploaded on the website of Directorate of Women and Child Development, H.P. (<https://wcdhp.nic.in>). No further objection will be entertained after issuing said seniority list.
