



No. HFW-B(A)2-30/2018.—In exercise of the powers conferred by proviso to Article 30 of the Constitution of India, the Governor, Himachal Pradesh, in consultation with the Himachal Pradesh Public Service Commission, is pleased to make the Recruitment and Promotion Rules for the post of Clinical Psychologist, Class-I (Gazetted) in the Department of Medical Education and Research, Himachal Pradesh as per Annexure-"A" attached to this notification, namely:—

1. Short title and commencement.—(i) These rules may be called the Himachal Pradesh Department of Medical Education and Research, Clinical Psychologist, Class-I (Gazetted) Recruitment and Promotion Rules, 2021.

(ii) These rules shall come into force from the date of their publication in the Rajpatra (e-Gazette), Himachal Pradesh.

2. Repeal & savings.—(i) The Health Department (Medical Education), Himachal Pradesh Clinical Psychologist, Class-I (Gazetted) Recruitment and Promotion Rules, 1997 notified vide Notification No. Health-A(3)-1/96 dated 31-01-1997 are hereby repealed.

(ii) Notwithstanding such repeal any appointment made or any thing done or any action taken under the rules so repealed under rule 2 (i) *supra* shall be deemed to have been validly made, done or taken under these rules.

“ANNEXURE-A”

RECRUITMENT AND PROMOTION RULES FOR THE POST OF CLINICAL PSYCHOLOGIST CLASS-I (GAZETTED), UNDER THE MEDICAL EDUCATION & RESEARCH DEPARTMENT, HIMACHAL PRADESH

1. **Name of post.**—Clinical Psychologist
2. **Number of post(s).**—01
3. **Classification.**—Class-I (Gazetted)
4. **Scale of Pay.**—(i) *Pay Band for regular incumbents:* Pay Band Rs.10,300—34,800 + 5000/- Grade Pay.
(ii) *Emoluments for contract employee(s):* Rs. 15,300/- per month as per details given in Column No. 15-A.
5. **Whether “Selection” post or “Non-Selection” post.**—Not applicable
6. **Age for direct recruitment.**—Between 18-45 years:

Provided that the upper age limit for direct recruits will not be applicable to the candidates already in service of the Government including those who have been appointed on *ad hoc* or on contract basis:

Provided further that if a candidate appointed on *ad hoc* basis or on contract basis had become over-age on the date he / she was appointed as such, he / she shall not be eligible for any relaxation in the prescribed age-limit by virtue of his / her such *ad hoc* or contract appointment;

Provided further that the upper age-limit is relaxable for Scheduled Castes / Scheduled Tribes / Other Backward Classes/Other categories of persons to the extent permissible under the general or special order(s) of the Himachal Pradesh Government;

Provided further that the employees of all the Public Sector Corporations and Autonomous Bodies who happened to be Government Servant before absorption in Public Sector Corporations / Autonomous Bodies at the time of initial constitution of such Corporations/Autonomous Bodies

shall be allowed age concession in direct recruitment as admissible to Government servants. This concession will not, however, be admissible to such staff of the Public Sector Corporations/ Autonomous Bodies who are/were finally absorbed in the service of such Corporations/ Autonomous Bodies after initial constitution of the Public Sector Corporations/Autonomous Bodies.

Note.—Age limit for direct recruitment will be reckoned on the first day of the year in which the post(s) is / are advertised for inviting applications or notified to the Employment Exchanges or as the case may be.

7. Minimum educational and other qualifications required for direct recruit(s).—(a) *Essential Qualification(s).*—(i) Post-Graduate degree in Psychology or Clinical Psychology or Applied Psychology.

(ii) Master of Philosophy in Clinical Psychology or Medical and Social Psychology obtained after completion of a full time course of two years which includes supervised clinical training from any University recognized by the University Grants Commission established under University Grants Commission Act, 1956 (3 of 1956) and approved and recognized by the Rehabilitation Council of India Act, 1992 (34 of 1992).

Desirable qualification(s).—Knowledge, customs, manners and dialect of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.

8. Whether age and educational qualification(s) prescribed for direct recruit(s) will apply in the case of the promotee(s).—*Educational Qualification* : Not applicable.

9. Period of probation, if any.—(a) Two years subject to such further extension for a period not exceeding one year as may be ordered by the competent authority in special circumstances and reasons to be recorded in writing.

(b) No probation in case of appointment on contract basis.

10. Method(s) of recruitment, whether by direct recruitment or by promotion/ secondment/ transfer and the percentage of post(s) to be filled in by various methods.—100% by direct recruitment on a 'regular' basis or by recruitment on contract basis, as the case may be.

11. In case of recruitment by promotion/ secondment/ transfer, grade from which promotion / secondment/ transfer is to be made.—Not Applicable.

12. If a Departmental Promotion Committee exists, what is its composition? :

Departmental Promotion Committee.—Not applicable.

Departmental Confirmation Committee.—As may be constituted by the Government from time to time.

13. Circumstances under which the Himachal Pradesh Public Service Commission is to be consulted in making recruitment.—As required under the Law.

14. Essential requirement for a direct recruitment.—A candidate for appointment to any service or post must be a citizen of India.

15. Selection for appointment to post by direct recruitment.—Selection for appointment to the post in the case of direct recruitment shall be made on the basis of interview/ personality test or if the Himachal Pradesh Public Service Commission or other recruiting agency/authority as the case may be, so consider necessary or expedient on the basis of interview/personality test preceded by a screening test (objective type)/ written test or practical test the standard/syllabus, etc. of which, will be determined by the Commission/ other recruiting agency/ authority as the case may be.

15-A. Selection for appointment to the post by contract appointment.—Notwithstanding anything contained in these Rules, contract appointments to the post will be made subject to the terms and conditions given below:—

(I) CONCEPT.—(a) Under this policy the Clinical Psychologist, in department of Medical Education and Research, H.P. will be engaged on contract basis initially for one year; which may be extendable on year-to-year basis:

Provided that for extension / renewal of contract period on year to year basis the concerned HOD shall issue a certificate that the service and conduct of the contract appointee is satisfactory during the year and only then his period of contract is to be renewed / extended.

(b) *Post falls within the Purview of HPPSC.*—The Administrative Secretary (Health) to the Government of Himachal Pradesh after obtaining the approval of the Government to fill up the vacant posts on contract basis will place the requisition with the concerned recruiting agency i.e. the Himachal Pradesh Public Service Commission.

(C) The selection will be made in accordance with the eligibility conditions prescribed in these R&P Rules.

(II) CONTRACTUAL EMOLUMENTS.—The Clinical Psychologist appointed on contract basis will be paid consolidated fixed amount @ Rs.15,300/- per month (which shall be equal to minimum of the pay band + grade pay). An amount of Rs. 459/- (3% of the minimum of pay band + grade pay of the post) as annual increase in contractual emoluments for the subsequent year(s) will be allowed if contract is extended beyond one year.

(III) APPOINTING / DISCIPLINARY AUTHORITY.—The Administrative Secretary (Health) to the Government of Himachal Pradesh will be the appointing and disciplinary authority.

(IV) SELECTION PROCESS.—Selection for appointment to the post in the case of contract appointment will be made on the basis of interview/personality test or if considered necessary or expedient on the basis of interview/personality test preceded by a screening test (objective type)/ written test or practical test or physical test, the standard/ syllabus etc. of which will be determined by the concerned recruiting agency i.e. Himachal Pradesh Public Service Commission.

(V) COMMITTEE FOR SELECTION OF CONTRACTUAL APPOINTMENTS.—As may be constituted by the concerned recruiting agency i.e. the Himachal Pradesh Public Service Commission from time to time.

(VI) AGREEMENT.—After selection of a candidate, he / she shall sign an agreement as per Annexure-B appended to these Rules.

(VII) TERMS AND CONDITIONS.—(a) The contractual appointee will be paid fixed contractual amount @ Rs.15,300/- per month (which shall be equal to minimum of pay band +
