बाल/बालिका सुरक्षा योजना

1.शीर्षक:

यह योजना हिमाचल प्रदेश बाल/बालिका सुरक्षा योजना-2012 कहलायेगी।

2. उद्देश्य:

इस योजना का मुख्य उद्देश्य अनाथ/असहाय बाल/बालिकाओं को जिला कार्यक्रम अधिकारी/बाल विकास परियोजना अधिकारी की देखरेख में किसी सम्पन्न परिवारिक वातावरण में पालने हेतु रखा जाना है ताकि जन्म बाल/बालिका आश्रमों में प्रवेश हेतु वाध्य न होना पड़े। अबधि बालक की आवश्यकता पर निर्मर होगी। परिवार में रखने हेतु प्रक्रिया जिला कार्यक्रम अधिकारी द्वारा निर्धारित फार्म—16 एंव 17 अनुबन्ध"क" के अनुसार संपन्न की जाएगी।

3. पात्रताः

3.1

(i) दम्पती एवं लाभान्वित बच्चा दोनों हिमाचल प्रदेश के स्थाई निवासी हा। चाहिए।

(ii) वोनों वन्पति की आयु 105 वर्ष से अधिक न हो, परन्तु मात्वंश एवं पैतृकवशं के प्रकरण में आयु की कोई सीमा शर्त नहीं होगी।

(iii) पालन दन्पती परिवार स्थिर भावात्मक समाधान वाला हो।

(iv) दम्पति /परिवार की आमदनी 5,000/— रू0 प्रति माह से कम नहीं होनी चाहिए परन्तु मातृवशं एवं पैतृवशं में आमदनी की कोई सीमा शर्त लागू नहीं होगी ।

दम्पती तथा परिवार में रहने वाले सदस्यों को एच०आई०वी०, टी०वी० तथा (v) हेपेटाईटस वी बारे चिकित्सा रिपोर्ट प्राप्त करनी होगी। पालना दम्पती को बच्चों को पालने का अनुभव होना चाहिए तथा (vi) बालक / बालिकाओं की अच्छी तरह देखभाल करने की क्षमता हो। दम्पती मानसिक, शारीरिक एवं भावनात्मक वृति से स्वस्थ हो। (vii) घर में मूलभूत सुविधायें एवं पर्याप्त स्थान हो। (viii) पालना परिवार को नियमानुसार बच्चे का स्वास्थ्य जाँच एंव रिकार्ड रखना होगा (ix) तथा नियमित बालचिकित्सक की देखभाल सुनिश्चित करनी होगी। पालना परिवार को लिखित में सहमति पत्र देना होगा कि जब चाहा जायेगा बच्चे (x) को दत्तक ऐजैन्सी को भेजा जाये या बच्चे को वापिस किया जायेगा। पालना परिवार प्रशिक्षण या ओरियन्टेंशन कार्यक्रम पर जाने हेतु सहमत हो। (xi) पालना परिवार यदि बच्चा छोटा हो तो माह में एक बार नियमित बाल चिकित्सक (xii) जो दत्तक एजैंन्सी द्वारा अनुमोदित हो से जॉच करवाएगा। साल में एक बार मध्यन्तर में पालना हेतु नवीनतम अनुमति प्राप्त करनी होगी । (xiii) पालना परिवार बाल कल्याण कमेटी द्वारा फार्म-16 के अनुसार अनुमोदित हो । (xiv) अनाथ/असहाय बाल/बालिका के रिश्तेदार दादा-दादी/ नाना-नानी/ (XV) ताया-ताई/चाचा-चाची/मामा-मामी/ मासी-मासड़/ फुफी-फुफड़/ भाई-भाभी/ बहन-जीजा भी पात्र होगें। अनाथ/असहाय बाल/बालिका के मातृवंश एवं पैतृवशं में एकाकी महिला (xvi) सदस्य जो 3.1(xv) में वर्णित है भी पात्र होगी। एकाकी महिला सदस्य क अलावा मातृवंश एवं पैतृवंश के पुरूष नाना या दादा ही पात्र होगें ।

दम्पती/परिवार के चयन हेतु किसी भी जाति, धर्म,अथवा अक्षमता को आधार नहीं माना जाएगा तथा जिला स्तर पर गठित बाल कल्याण कमेटी द्वारा चयनित किया जाएगा। यदि आपसी सम्बन्धों में समायोजन में कठिनाई आती है तो सम्बन्धित बाल विकास परियोजना अधिकारी/ जिला कार्यक्रम अधिकारी द्वारा उन्हें आवश्यक परामर्श दिया जायेगा।

If couple - Length of married life, what qualities does each applicant bring to the partnership, what makes the relationship positive for each other? Within the relationship how do applicants cope with problems/stress/anger? How do applicants support each other? What is each applicant's assessment of how the foster placement will affect his or her relationship?

Decision making:

How is decision - making exercised in this relationship and how does each of the applicants view this? Is there wider extended family involvement in the couple's decision-making process? If so, how will this affect the child to be placed?

Social workers assessment:
