## TERMS AND CONDITIONS

1. Sealed tender indicating therein the price offered for the above mentioned vehicle, should be accompanied by Demand Draft on account of EMD in the name of H.P. Wool Federation Ltd., Palampur, payable at Palampur for Rs. 5000/- (Rs. Five thousand only). Cheques/Cash shall not be accepted. The tenders without earnest money will be rejected without assigning any reason. The earnest money of unsuccessful tenderers will be refunded.
2. As soon as the tender is approved/accepted the concerned tenderer will have to deposit full amount of the price quoted in shape of Demand Draft/RTGS in favour of this Federation failing which his/her tender would be treated as cancelled/rejected and the earnest money deposited by him/her would be forfeited without any further notice.
3. Successful tenderer will have to remove/take delivery of the said vehicle, old tyres, spare parts and batteries etc. from the premises of Wool Grading & Marketing Centre, Palampur (Banuri) immediately after depositing the full money failing which 5% extra money will be charged per day of tender money /offer and thereafter the office will not be responsible for the security of the auctioned vehicle.
4. Conditional tenders shall be rejected out rightly.
5. The RC of the vehicle stands cancelled, hence the vehicle has to be lifted on salvage basis.
6. If the above mentioned vehicle is not sold off on the basis of sealed tenders for any reason, then the vehicle, old tyres, spare parts and batteries etc. will be put to open auction on the same day i.e. **30.03.2021 on 2.30 PM**. The open auction will start from the reserve price fixed by the condemnation board.
