Regarding Policy for grant NOC to the deserving doctors prior to Joining.

Sir,

I am directed to address you on the subject cited above and to state that in the year 2017 the policy has been notified by the Government to regulate the terms & conditions for the GDOs for pursuing PG(MD/MS) Degree/Diploma & Master Courses, Super Specialty DM/MCh Courses, DNB Courses within & outside the State. As per the policy the candidate has to furnish a bond in the form of Bank Guarantee prior to joining the course. Many representations/ requests have been received from candidate wherein it is requested that instead of bank guarantee they may be allowed to furnish FD as service charges realized by the bank for bank guarantee is on a very higher side. The matter has been examined by the Government and it has been decided that till a final decision in the matter may be taken, following interim relief is granted to the candidates:-

- The last date of Bank Guarantee is extended till 31st of January, 2018. (1)
- The selected doctors should be grant necessary permissions/NOC/ (2) relieving to join PG(MD/MS) Degree/Diploma & Master Courses, Super Specialty DM/MCh Courses, DNB Courses subject to the condition that they will furnish an affidavit duly attested by notary/ Executive Magistrate to the effect that they will deposit security/ bond to the Government by 31st January, 2018 as per the policy of the Government.
