**NOTICE FOR POSTGRADUATE (MD/MS ) COUNSELLING -2018 FOR 50% STATE QUTOA SEATS IN GOVT. MEDICAL COLLEGES AND ALL SEATS IN PVT. MEDICAL COLLEGES ON THE BASIS OF NEET-(PG)-2018 RANKING /MARKS.**

The Department of Medical Education shall conduct Centralized Counselling through Centralized Counselling Committee constituted by the State Govt. for filling-up of 50 % State Quota PG (MD/MS ) degree seats in Government Medical Colleges and all seats in private Medical College as per State merit drawn by the **Principal Indira Gandhi Medical College Shimla -cum Member Secretary Counselling Committee(MD/MS)** on the basis of score NEET(PG)-2018 of those candidates who will apply on the prescribed application form within stipulated date as mentioned in the prospectus for admission to PG (MD/MS) degree courses to the Principal, IGMC, Shimla-cum-Member Secretary Counselling Committee for the academic session 2018-2021 .

**Procedure for obtaining Prospectus -cum- Application Form**

The prescribed Application form and Prospectus for PG (MD/MS)Counselling can be obtained from the **Office of Principal, Indira Gandhi Medical College, Shimla w.e.f. 15.3.2018** during working days on cash payment of Rs. 1500/- for General and Rs. 1000/- for SC/ST categories.

All the NEET-PG-2018 qualified candidates who fulfills the eligibility criteria and other terms and conditions as laid down in the Prospectus PG (MD/MS) Counselling-2018 are required to submit their application forms ( in original) on or before **30.3.2018** to the **Principal Indira Gandhi Medical College, Shimla-171001** . The In-service HPHS (GDO) candidates (Regular /contract/RKS) are required to submit their application form alongwith "**No objection Certificate**" from the competent authority as per **Appendix-4** of Prospectus. Qualifying criteria for applying 50% State quota PG(MD/MS) Counselling -2018 is as under :-

d. General Category	50 <sup>th</sup> percentile
e. SC/ST	40 <sup>th</sup> percentile
f. Person with Disability	45 <sup>th</sup> percentile

Candidates less then above percentile in NEET (PG)-2018 are not eligible to apply for the Counselling .

**Note:** It will be the entire responsibility of the candidates to procure the Prospectus and submit the Application form within the stipulated date. The Department of Medical Education & Research, H.P. and the Principal, Indira Gandhi Medical College, Shimla-cum-Member Secretary Counselling Committee will not be responsible for any delay for non-receipt/misplacement /loss of Prospectus /application form in transit.
