"OFFICE ORDER"

On the prior approval of the Chief Electoral Officer HP, and also on the recommendation of the Departmental Promotion Committee, the following Ward Sisters are hereby promoted from waiting panel to the post of Matron in the Pay Band of Rs.10300-34800+4200 GP in the pre-revised scale of 2006 and level -12, in the revised pay scale as notified by the finance Department vide Notification dated 03.01.2022, on regular basis and posted in the Institutions as mentioned against their names with immediate effect, subject to the conditions that there is no complaint/ inquiry/ vigilance case and disciplinary proceedings are pending against the individual concerned:-

The above named officials will join their duty at new place of posting within 15 days failing which the promotion orders as Matron shall be deemed to have been withdrawn for ONE YEAR or next DPC whichever is later. If the promoted as Matron is not willing to avail the promotion the head of the concerned institution will take the option of non-availing the promotion from the concerned Ward Sister. The copy of same will be pasted

in her service book and the other copies be sent to this Directorate for taking further action. In case the concerned promotee does not report for duty in the institution within stipulated period, the next incumbent in panel will be promoted. The Head of the concerned will ensure the submission of joining/non-joining report to this Directorate within a week after the expiry of stipulated period.

The Head of the concerned institutions are directed to relieve the newly promotee immediately. Before relieving the official to join at the new place of posting on promotion, the Head of the concerned Institutions may ensure that the service particulars of every promotee be verified carefully viz Name, Seniority No, Category (SC/ST/Gen), there is no Departmental inquiry/ vigilance case should be pending against the said officials.

The head of the concerned institution shall take an undertaking of the concerned official to the effect that if he/she found unfit for promotion at a later stage due to any reason i.e. any change in the seniority/ disciplinary proceedings etc. he/she will be reverted to the original post of Ward Sister and the excess amount paid to him will be recovered in Lump-sum. The same be pasted in service book of concerned official duly countersigned by the Head of the Institution. If any discrepancy on any account comes to the notice then relieving / joining may not be accepted and the matter may be brought in the notice of HOD for further necessary action. All the Head(s) shall ensure that complete charge held by the promotee(s) is properly handed over before the relieving.

The financial benefits will be admissible from the date of joining on the post of Matron. She will be entitled TA/DA and joining time as admissible under the Rule. She will have to exercise his/her option within one month from the date of promotion for fixation of pay under Rule FR 22(i) a(i).


