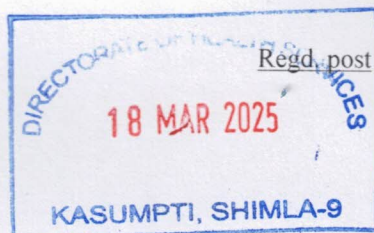

- 4 Candidates are also advised to visit the Health Department Website from time to time for updates in their own interest.

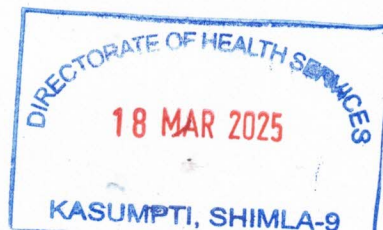
