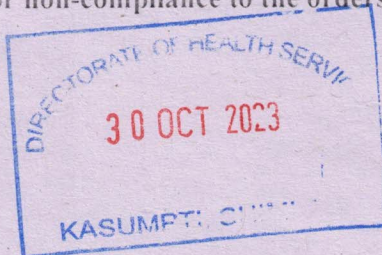

The above officials will report their duty at their new place of posting within fortnight from the issue of these orders failing which the promotion order shall be treated as withdrawn automatically without any further notice.
