These orders are available on the website www. hphealth.nic.in Terms and Condition for Regularization is as under:-

- 1. The post is temporary but likely to be continued. His /her regularization to the cadre is subject to review by the Government.
- 2. No TA/DA will be admissible for joining the service at his / her place of posting unless and otherwise admissible under rules.
- 3. The candidate will have to serve the Department anywhere in HP and he/she may also to serve in difficult area notified, for a minimum period of 3 years.
- 4. The candidate concerned shall have to produce the certificate of his/her being citizen of India.
- 5. The concerned candidate will have to take an oath of allegiance and faithfulness to the Constitution of India.
- 6. The Candidates' regularization /retention in service is subject to his/ her character and antecedents being found satisfactory through the concerned Head of the Institution within stipulated period of three months.
- 7. The concerned candidate shall have to produce a character certificate from a Tehsildar/Naib Tehsildar.
- 8. The concerned candidate will furnish a declaration to the effect that he/she is not a dismissed employee of any Govt. / Semi Govt. Department / Organization.
- 9. The concerned candidate will furnish a declaration to the effect that he / she has one living spouse.

any discrepancy comes to the notices at a later stage.
