- No TA/DA will be admissible for joining the service at his / her place of posting unless 2. and otherwise admissible under rules.
- The candidate will have to serve the Department anywhere in HP and he/she may also to serve in difficult area notified, for a minimum period of 3 years. 3.
- The candidate concerned shall have to produce the certificate of his/her being citizen of 4.
- The concerned candidate will have to take an oath of allegiance and faithfulness to the 5.
