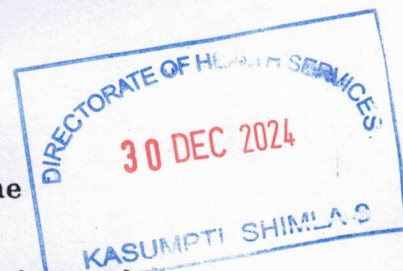

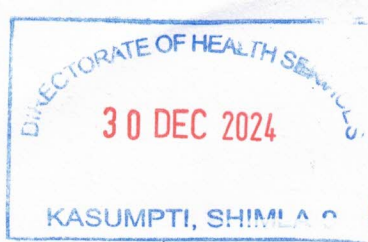

The posting orders of above officials as Female Health Supervisor will be issued separately (except serial number-30 & 37).

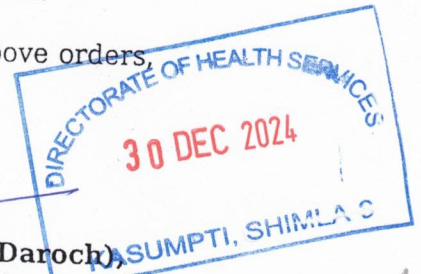
Note:-
