The above officials may submit their OPTION for fixation of their pay under Rule FR-22(1)a(i) within a period of one month

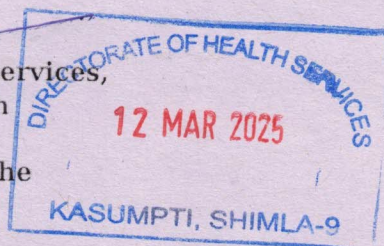
from the date of issuing of promotion orders as Female Health Supervisor. All the Female Health Supervisors (Except Sr. No. 1, 2, 3, 5, 8, 9, 10, 11, 15 and 17) will be entitled for TTA and joining time as admissible under the rules. The salary of the officials appeared at Sr. No. 8, 10 and 17 will be claimed against the equivalent/higher post from the institutions concerned. Further, the salary of official appeared at Sr. No. 14 will be claimed against the equivalent/higher post from the institution concerned till the vacancy to be caused on the retirement of present incumbent on 31.03.2025.

All the above officials will report their duty at their new place of posting within 05 days from the issue of these orders failing which the promotion order shall be treated as withdrawn automatically without any further notice.

NOTE:-

The concerned DDO's are requested to relieve the officials within stipulated period and their relieving/ joining may be intimated to this Directorate with due course of time, failing which defaulting officers shall be responsible for non-compliance to the orders.
