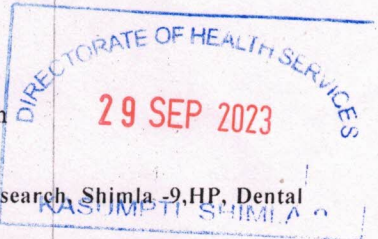
I am directed to refer to your letter No. Swa-Ni(1)Kh(2)1/91-7955&2234 dated 3.12.2022 & 1.05.2023, on the subject cited above and to say that the matter was taken up with Finance Department(Pay Revision) who observed that the category of Chief Laboratory Technician was in the pay scale structure of Rs. 5480-8925 w.e.f. 01.01.1996 which was further revised to Rs. 10300-34800+3600 GP by way of Conversion under the HPSC(RP) Rules, 2009. This category was also granted the higher grade pay of Rs. 4200 in the pay band of Rs. 10300-34800 under the HPSC(Category/postwise) Rules, 2012 w.e.f. 01.05.2013. Since, this post of Chief Lab Technician is being filled up 100% by way of promotion from amongst the Sr. Lab Technicians, therefore, the condition of higher Pay Band/Grade Pay after completions of two years was not inserted under the Pay Rules, 2012. Furthermore, during 2017, the nomenclature of both these posts i.e. Chief Lab Technician and Sr. Lab Technician was changed as Medical Lab Technician Gr-I and Medical Lab Technician Gr-II respectively in the PB/GP of Rs. 10300-34800+4200GP and 5910-20200+3000GP respectively w.e.f. 01.01.2018 under the Pay Rules, 2012. Now, since the Pay Matrix Level under the Pay Rules, 2022 needs to be determined keeping in view the Grade Pay of a post under HPSC(RP) Rules, 2009, therefore, the Department is advised that the pay scale of the Medical Lab Technician Gr-I promoted after 01.01.2018 will have to be determined in the pay matrix corresponding to the Grade Pay of Rs. 3600 under the HPSC(RP) Rules, 2022.

You are, therefore, requested to take further necessary action in view of above advice tendered by Finance Department.
