Regarding registration of paramedical with HP Paramedical Council.

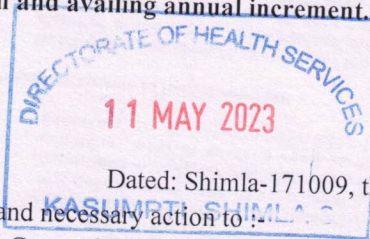
Sir/Madam,

In reference to the Registrar, HP Paramedical Council letter No. HPPMC NO. 7844 dated 06.04.2023 on the subject cited above.

In this context, it is intimated that registration of all the Paramedical listed in the scheduled of HP Paramedical Council Act, are statutorily required to get themselves registered with HP Paramedical Council as per section 38 of HP Paramedical Council Act, 2003. Some of Paramedical who are working in Government Sector i.e Medical Colleges, Zonal Hospitals, Distt. Hospitals, Civil Hospitals, Community Health Centre, PHCs, ESI Dispensaries & other Govt. Health Institutions are not registered on the State register of HPPMC as paramedical practitioners. Therefore, it is mandatory for all paramedical practitioners working in Government Sector, to get them registered on the State register of HP Paramedical Council as paramedical practitioners. As per section of 38 of HP Paramedical Council Act No. 21 of 2003, it is mandatory for every registered paramedical practitioner shall renew his / her registration after every three years.

As per the decision of the General body meeting of the HP Paramedical Council held on dated 31.01.2023 under the Chairmanship of Director Medical Education & Research cum President HP Paramedical Council. It has been decided that registration of all Paramedical working in Government sector i.e Medical Colleges, Zonal Hospitals, Distt. Hospitals, Civil Hospitals, Community Health Centre, PHCs, ESI Dispensaries & other Govt. Health Institutions should be registered/ renewal with HP Paramedical Council. This registration/ renewal with the HP Paramedical Council shall be compulsory on promotion and availing annual increment.

You are, therefore requested to inform all the paramedical staff working under your control to register/ renewal her/him with Council and now it is mandatory to all paramedical staff to register/ renewal for promotion and availing annual increment.
