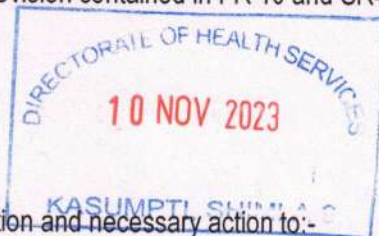
The above-mentioned Staff Nurses will submit their joining report at their original present place of posting on regularization.

The cases of left out Staff Nurses if any will be considered separately & if any discrepancies noticed at any stage must be brought into the notice of this office so that the facts could be rectified accordingly.

The above appointment shall be subject to the following terms and conditions: -

1. The post is temporary but likely to be continued. His /her regularization to the cadre is subject to review by the Government.
2. No TA/DA will be admissible for joining the service at her place of posting unless and otherwise admissible under rules.
3. The candidate will have to serve the Department anywhere in HP and she may also to serve in difficult area notified, for a minimum period of 3 years.
