**OFFICE ORDER**

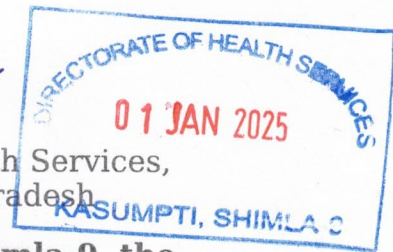
