 - b) Certificate of Educational Qualification i.e. B.Com or B.Sc/B.A. with Economic/Mathematics/Statistics from any recognized University/proof of age thereof..
 - c) Character Certificate from the Magistrate 1st Class.
 - d) Certificate of Bonafide Resident of Himachal Pradesh.
 - e) A Certificate if he/she belongs to SC/ST/OBC/ from the competent authority.
 - f) A declaration that candidate have not/shall not have more than one living husband/wife.
 - g) A declaration to the effect that if any of the information or documents submitted by him/her proved to be false, his/her services will be terminated without any further notice.

- h). Appointment is subject to the verification of his/her Character Antecedent.
i). No TA/DA will be allowed for joining the duty.
3. The regularization will be strictly on the basis of seniority subject to the condition that eligibility criteria etc. prescribed in the Recruitment and Promotion Rules for the post have been observed at the time of his initial recruitment on contract.
4. The regularization will be prospective effect i.e. from the date of issue of regularization orders.

If the above terms and condition are acceptable to him, should report for duty at their respective places of posting as shown above against their names within 07 days failing which the offer shall be treated as cancelled, without further notice.

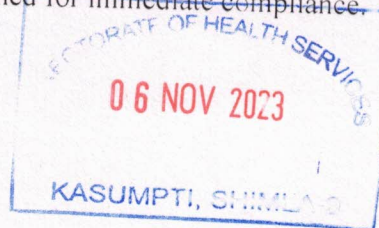


