## "OFFICE ORDER"

Pursuant to the approval conveyed by the Government vide letter No. Health-A-B(2)-48/2018-L dated 24/10/2024, for extending employment assistance on compassionate grounds in favour of the petitioner, Sh. Sunil Dutt, to the post of Class-IV on daily wage in relaxation of the ceiling of 5% quota meant for employment on compassionate grounds, in order to comply with the judgment dated 11-10-2023 in CWP NO. 2844/2023, ,Sh. Sunil Dutt, S/o Lt. Sh. Jagdish Kumar, R/o Village-Mandi, PO- Kothipura, Tehsil- Sadar, Distt. Bilaspur, Himachal Pradesh, is hereby offered appointment to the post of Class-IV on daily wage basis on compassionate grounds as per terms and conditions given below.

- 1. He will be paid @ 400/- (Rs. Four Hundred) only per day as per prescribed by the State Government from time to time.
- 2. The appointment is purely on daily wages and the candidate is liable to be resign at any time by serving at least one month notice from either side viz a viz the appointee or appointing authority.

3. The appointment is with the condition that the appointee can be posted/directed to serve in any part of District Bilaspur being the District cadre.

- 4. The appointment is further subject to the production of following certificate/documents by Sh. Sunil Dutt, before the Office Incharge of his place of posting before joining his duty:-
- a) Certificate of Medical Fitness issued by the Medical Superintendent, RH Bilaspur.
- b) Certificate of Educational Qualification (i.e. matriculation) from any recognized Board/University/proof of age thereof.
- c) Character certificate from the Magistrate 1st Class or any Gazetted Officer.
- d) Certificate of Bonafide Resident of Himachal Pradesh.
- e) A certificate if he belongs to SC/ST/OBC/WFF/IRDP/EWS/Person with benchmark disability from the competent authority.
- f) He will submit the certificate of total income from all sources and Legal Heirs certificate issued by the competent authority submitted by him at the time of date of submission of his application for compassionate employment.
- g) A declaration that candidate has not/shall not have more than one living wife.
- h) An undertaking to the effect that he shall give full support to the member of the family of the deceased Government employee for all the time.
- i) A declaration to the effect that if any of the information or documents submitted by him proved false, his services will be terminated.

- j) He will produce non employment certificate to the effect that no dependent family members of the deceased is in Government service. The controlling Officer shall ensure that if any family member of the deceased is in Government services, joining may not be accepted and the matter may be brought into the notice of the undersigned.
- k) The appointment is subject to the verification of his character antecedent.
- I) The concerned appointee will be entitled to TA/DA if required to go on tour in connection with his official duties.
- m) No TA/DA will be allowed for joining the duty.

If above terms and conditions are acceptable to him, Sh. Sunil Dutt, should report for duty at the office of Medical Superintendent RH Bilaspur, Distt. Bilaspur within 15 days from the date of issuance of this order, failing which the offer will be treated as cancelled.
