Sir,

In continuation of this Ministry's letter dated 22.10.2019, I am directed to convey the sanction of the President of India for release of an amount of **Rs. 19,49,88,000/- (Rupees Nineteen Crore Forty-Nine Lakh Eighty-Eight Thousand Only)**, to the Government of Himachal Pradesh towards Creation of Capital Assets (CCA) for Grants under Article 275(1) of the Constitution for the year 2019-20 to carry out the following activities:

3. The expenditure to the tune of **Rs. 19,49,88,000/- (Rupees Nineteen Crore Forty-Nine Lakh Eighty-Eight Thousand Only)**, is debitible to the :

4. The State Government will implement the projects within the amount released by the Ministry during 2019-20 and keeping in view the spirit of the provisions contained under Operational Guidelines for Inter-State allocation of funds and implementation of Programmes / Activities under Proviso to Article 275(1) of Constitution of India, issued by Ministry of Tribal Affairs vide this Ministry's letter NO. 11015/01/2016-SG-I dated 20.6.2016 and other relevant instructions issued from time to time.

5. State Government shall ensure immediate transfer of funds to respective implementing agencies for implementation of activities to be approved by MoTA PAC / Competent Authority. Progress Reports of Grants under Article 275(1) of Constitution of India may be furnished in the format prescribed by MoTA. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry as per provisions of General Financial Rules (GFR), 2017 amended from time to time.

6. Article 275(1) Grants is an additive to State Plan funds and efforts for Tribal Development. Funds under Article 275(1) Grants must be utilized for raising socio-economic level of Schedule Tribes commensurate with objectives enshrined in para 2.2 read with para 3.2 of revised guidelines dated 20.06.2016.

7. The State Government has to ensure that grant-in-aid is used for the purpose for which it is sanctioned after following due procedure in a transparent manner and after obtaining all necessary clearances as required under the various Central/ State Acts, Rules, regulations, etc. In case of construction of infrastructure facilities, norms and Schedule of Rates (SOR) fixed by the State Government should be followed.


8. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated and revised from time to time. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry within 12 months of the closure of the financial year by the State Government.


