Sir,

In supersession of earlier sanction order of even number dated 27.01.2022, I am directed to convey the sanction of the Competent Authority for the release of an advance of Rs. 474,00,00,000 (Rupees four hundred seventy four crore only) to States as per list attached, at the rate of Rs. 20 lakh per AMRUT city and Rs. 10 lakh per non-AMRUT city as per AMRUT 2.0 guidelines as part of State funds for Administrative & Other Expenses (A&OE) for preparation of City Water Balance Plan (CWBP) under AMRUT 2.0 for the year 2021-22.

- 2. The amount of advance is out of the ULBs share of A&OE funds allocated for the Mission period and will be adjusted in their share at the time of release of further installment. The fund should be utilised for the purpose of A&OE component of AMRUT 2.0 for which it has been released. The diversion of Central Grants for purposes other than the A&OE component of AMRUT 2.0 is not allowed and shall entail levy of penal interest on the amount and any other action by the Apex Committee and may include adverse effect on release of Grants.
- 3. The Utilization Certificate for the advance released should be submitted as per the provisions of GFR along with details of item-wise expenditure.
- 4. Certified that no Utilization Certificate is pending in respect of the States mentioned in the attachment as per requirement since, AMRUT 2.0 has been launched on 01.10.2021.
- 5. State Governments should ensure that there is no violation of Model Code of Conduct of Election Commission of India while releasing funds to implementing Agencies/ULBs/Beneficiaries.

- 6. This release will be governed in terms of provisions of GFR. The amount of Central Grant should be kept in separate account and be open to inspection/Audit as per provisions.
- 7. The expenditure involved is debitable to Major Head 3601 Grant in Aid to State Govts, 06 Centrally Sponsored Plan Scheme, 101- Central Assistance/Share, 24-Urban Rejuvenation Mission- 500 Habitations (AMRUT), 24.01.31-Grants-in-aid General under Grant No. 59 Ministry of Housing & Urban Affairs for the year 2021-22 (Plan).
- 8. The amount will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22.02.1977.
- 9. The sanction has been entered at Sl. No. 14 of the sanction register of AMRUT Division for FY 2021-22.
- 10. This issues with the concurrence of IFD vide e-file No.9118080, dated 19.01.2022.
