Sub: Centrally Sponsored Scheme "Assistance to States for Control of Animal Diseases (Animal Disease Control)" – Release of Central Assistance during the year 2016-17 to the State Government of Himachal Pradesh – regarding.

Sir,

I am directed to refer to the subject cited above and to convey the Administrative Approval for the Centrally Sponsored Scheme "Assistance to States for Control of Animal Diseases (Animal Disease Control)" at a total cost of Rs. 533.10 Lakh (Rupees Five Crores Thirty Three Lakh Ten Thousands only) of which Rs. 480.33 Lakh (Rupees Four Crore Eighty Lakh Thirty Three Thousand only) being the central share and sanction of the President of India for the payment of Grants-in-Aid amounting to Rs.123.00 Lakh (Rupees One Crore Twenty Three Lakh only) as first instalment to the Himachal Pradesh State Govt. towards expenditure on the Centrally Sponsored Scheme "Assistance to States for Control of Animal Diseases" (ASCAD), a component of Centrally Sponsored Scheme 'Livestock Health and Disease Control' release of central assistance for the current Financial Year (2016-17) with the condition that matching share of 10% is provided by the State Govt.

2. The Grants-in-Aid of Rs. 123.00 Lakh (Rupees One Crore Twenty Three Lakh only) have been released in accordance with the approved pattern of financial assistance under the Scheme. The release to the Himachal Pradesh State Govt. is subject to the condition that the next instalment for release will be considered only after obtaining the information relating to fund-utilization and submission of Utilization Certificate by the Chhattisgarh State Govt.

6. This Sanction is issued in exercise of delegated powers and with the concurrence of Finance Division of Ministry of Agriculture, Department of Animal Husbandry, Dairying & Fisheries vide their Diary No. 332/AS&FA/2016 dated 24.06.2016.

8. The audited figures of expenditure of the current financial year as well as previous years may please be furnished.
9. It is certified that the expenditure of Rs.123.00 Lakh (Rupees One Crore Twenty Three Lakh only) have been duly noted in the Expenditure Control Register at Sl.01 on Page 51 as stipulated in GFR Rule 212(4)(b).
10. It is certified that no Utilization Certification is pending with the above-mentioned State as due for rendition under the Rules under the Scheme.
