- 2. The Grants-in-Aid of Rs. 123.00 Lakh (Rupees One Crore Twenty Three Lakh only) have been released in accordance with the approved pattern of financial assistance under the Scheme. The release to the Himachal Pradesh State Govt. is subject to the condition that the next instalment for release will be considered only after obtaining the information relating to fundutilization and submission of Utilization Certificate by the Chhattisgarh State Govt.
