**Sub: Centrally Sponsored Scheme "Assistance to States for Control of Animal Diseases (Animal Disease Control)" – Release of Central Assistance during the year 2016-17 to the State Government of Himachal Pradesh – regarding.**

Sir,

In continuation of this Department's letter of even number dated 5<sup>th</sup> July, 2016, I am directed to convey the sanction of the President of India for the payment of Grants-in-aid amounting to Rs.27.00 Lakh (Rupees Twenty Seven Lakh only) as the first instalment to the State Government of Himachal Pradesh towards expenditure on the Centrally Sponsored Scheme "Assistance to States for Control of Animal Diseases" (ASCAD), a component of Centrally Sponsored Scheme 'Livestock Health and Disease Control' release of central assistance for the current Financial Year (2016-17) with the condition that 10% matching share will be provided by the State Govt. The funds have been released to implement the Special Component Plan for Scheduled Caste.

2. The Grants-in-Aid of Rs.27.00 Lakh (Rupees Twenty Seven Lakh only) have been released in accordance with the approved pattern of financial assistance under the Scheme. The release to the State Government of Himachal Pradesh is subject to the condition that the next instalment for release will be considered only after obtaining the information relating to fund-utilization and submission of Utilization Certificate by the Himachal Pradesh State Govt.
