Sub: - Release of sum of Rs. **22,50,00,000/- (Rupees Twenty two Crore Fifty lakh only)** as Grants-in-aid to the State Government of **Himachal Pradesh** under the scheme for Border Area Development Programme for the financial year 2016-17.

Sir,

I am directed to refer to the subject mentioned above and to convey the sanction of the President to release a sum of **Rs.225000000/- (Rupees Twenty two Crore Fifty lakh only)**, to the Government of Himachal Pradesh during the current financial year 2016-17 as 1st installment of Special Central Assistance (SCA) under Border Area Development Programme.

2. The sanction of **Rs.22,50,00,000/-** to the Government of **Himachal Pradesh** shall be debited to 3601 – Grants-in-aid to State Governments (Major Head) – 02 Grant for State Plan Scheme (Sub Major Head) -02.101 – Block Grants (Minor Head), 04-Special Central Assistance-Border Areas, 04.01 Border Area Development Programme (BADP)-04.01.35-Grants for creation of capital Assets under Demand No. 48-Police for the year 2016-17.

3. The amount is sanctioned subject to the condition that if this Ministry detects any discrepancies at a later stage by exercising a check to ensure the authenticity and accuracy of the expenditure, the same shall be adjusted against the State Government's pending/ future releases.

4. As per GFR rule 211 (1) the accounts of all grantee institutions or organizations shall be opened to inspection by the sanctioning authority and by the Internal Audit Wing of MHA, whenever the institution or organization is called upon to do so.

5. All the terms and conditions stipulated in the Administrative approval of the financial year 2016-17 have been followed.

6. The above amount will be released through ECS/RBI advice.

7. This issues with the concurrence of the Integrated Finance Division of this Ministry vide their letter Dy. No.CF-3348624/IFD (H) dated 02.06.2016.
