- 3. The amount is sanctioned subject to the condition that if this Ministry detects any discrepancies at a later stage by exercising a check to ensure the authenticity and accuracy of the expenditure, the same shall be adjusted against the State Government's pending/ future releases.
- 4. As per GFR rule 211 (1) the accounts of all grantee institutions or organizations shall be opened to inspection by the sanctioning authority and by the Internal Audit Wing of MHÅ, whenever the institution or organization is called upon to do so.
- 5. All the terms and conditions stipulated in the Administrative approval of the financial year 2016-17 have been followed.

- 6. The above amount will be released through ECS/RBI advice.
