**Subject:-** Release of 2<sup>nd</sup> instalment to the Government of Himachal Pradesh for construction of **01 SC girls hostel** at Institute of Biotechnological and Environmental Science, Neri, Hamirpur, Himachal Pradesh under the Centrally Sponsored Scheme of "**Babu Jagjivan Ram Chhatrawas Yojana**" during the year 2020-21 (Non-recurring).


I am directed to convey the approval of the President of India to release of 2<sup>nd</sup> instalment of Rs.57,95,055/- (Rs. Fifty Seven Lakh Ninty Five Thousand and Fifty Five only) during 2020-21 to the Government of Himachal Pradesh for construction of 01 SC hostel at Institute of Biotechnological and Environmental Science, Neri, Hamirpur, Himachal Pradesh for 94 inmates, under the Scheme of "**Babu Jagjivan Ram Chhatrawas Yojana**". The grant sanctioned is subject to terms and conditions mentioned in the letter. The details of the balance payment of 2<sup>nd</sup> instalment being released in this sanction for 01 (one) hostels are given at Annexure.

2. The expenditure is debitable to Demand No. 92-Ministry of Social Justice and Empowerment; Major Head 3601; 06- Centrally Sponsored Schemes (Sub-Major Head); 789-Special Component Plan for Scheduled Castes; 34.11-Girls Hostels; 34.11.35-Grants for creation of capital assets, for the year 2020-21.
3. Certified that sanction has been entered at **S. No. 08** (for MH 3601 -Girls /boys Hostel) in the register of Grants for 2020-21.
4. The Drawing and Disbursing Officer, Ministry of Social Justice and Empowerment will draw and disburse Rs. 57,95,055/- (Rs. Fifty Seven Lakh Ninty Five Thousand and Fifty Five only) to Govt. of Himachal Pradesh.
5. The Government of Himachal Pradesh shall comply with the terms and conditions of the "**Babu Jagjivan Ram Chhatrawas Yojna**" and the conditions laid down in the General Financial Rules, 2017 as amended from time to time.
6. The balance of the amount, if any remaining unspent towards the end of the current financial year is allowed to be carried forward for utilization during the next financial year. No cost over run will be allowed and if there is any, the same will be borne by the Grantee itself.
7. This sanction is subject to all the conditions in the Scheme. **The sanctioned hostels shall be completed within a period of two years from the date of sanction by the Ministry.** Requisite Physical and Financial Progress Report for all the Hostels should be submitted by the implementing agency along with next proposal. Operationalisation of the Hostel buildings completed should be reported by the organization. The proper utilization of funds and maintenance of the hostels would be the responsibility of the Implementing Agency.

The accounts relating to this grant shall be open for inspection by the sanctioning authority and audit, both by the Comptroller & Auditor General of India under the provision of C&AG (DPC) Act, 1971 and internal audit party by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.
9. Organization shall submit the Utilization Certificates in the prescribed format i.e. GFR- 12 C within 24 months of the closure of the current financial year.
10. The Physical progress and financial progress reports in the prescribed format in respect of above hostel must be furnished by the Organization quarterly.
11. The funds allocated under this Scheme cannot be diverted to any other programme without prior approval of Government of India.
12. This issues with the concurrence of I.F. Division of this Ministry vide their Dy. No.19616/JS&FA; dated: 28.08.2020.


