The State Government will furnish progress report indicating physical and financial achievement on quarterly basis till the coverage of all beneficiaries under the scheme and completion of the project. Besides, the State will also furnish utilization certificate in respect of the central grant released and utilized, failing which further release of central fund will not be considered.
 - c) The accounts regarding release of funds and their utilization shall be open to inspection by the Sanctioning Authority and Audit, both by the comptroller & Auditor General of India and internal audit of the Principal Accounts Office of this Ministry.
- The Government of Himachal Pradesh will ensure transfer of benefit to beneficiaries directly to their accounts in electronic mode through DBT platform and furnish the details of beneficiary name, Aadhaar number, mobile number, account number to this Department.
