Sub:- Release of Central funds to the Government of Himachal Pradesh for development of fisheries in the State under Centrally Sponsored Scheme on Blue Revolution: Integrated Development and Management of Fisheries during the financial year 2019-20.

Sir,

I am directed to convey the sanction of the President to release of 3rd and final installment (Part I) of central financial assistance of **₹43,50,500 (Rupees Forty Three Lakh Fifty Thousand and Five Hundred only)** to the Government of Himachal Pradesh for development of fisheries in the State under the Centrally Sponsored Scheme on Blue Revolution: Integrated Development and Management of Fisheries during the financial year 2019-20.

2. The revised Administrative Approval for implementation of the Centrally Sponsored Scheme on Blue Revolution: Integrated Development and Management of Fisheries with revised subsidy and subsidy sharing pattern has been notified vide this Ministry's letter No.27035-19/2015-Fy(IV)-Vol. III dated 1st January, 2018. Approval for continuation for the CSS during 2019-20 has also been notified vide this Department's Administrative Approval No. 27035-19/2015-Fy(IV)-Vol. III date 22nd April, 2019.

3 The administrative approval of Government of India to the proposal of Government of Himachal Pradesh for development of fisheries in the State under the CSS has been notified vide this Ministry's order of even number dated 9th May, 2018.

4. The Government of Himachal Pradesh shall ensure compliance of the terms and conditions stipulated in the approvals mentioned in para-2 and para-3 above.

5. The approval to the proposal is subject to the following terms and conditions:


a) The sanction of above mentioned amount will be governed by the provisions of the General Financial Rules, 2017 as amended from time-to-time.

b) The State Government will utilize the funds for the purpose for which it has been released. The State Government will furnish progress report indicating physical and financial achievement on quarterly basis till the coverage of all beneficiaries under the scheme and completion of the project. Besides, the State will also furnish utilization certificate in respect of the central grant released and utilized, failing which further release of central fund will not be considered.

c) The accounts regarding release of funds and their utilization shall be open to inspection by the Sanctioning Authority and Audit, both by the comptroller & Auditor General of India and internal audit of the Principal Accounts Office of this Ministry.

6. The Government of Himachal Pradesh will ensure transfer of benefit to beneficiaries directly to their accounts in electronic mode through DBT platform and furnish the details of beneficiary name, Aadhaar number, mobile number, account number to this Department.

7. The Further use of Grants-in-Aid being released by this sanction Order, is to be done through EAT module of PFMS. The Utilization Certificate not supported by the EAT module data is likely to be rejected and expenditure is not to be treated as regular. The agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of this Sanction Order.
