

5. Principal CCA's Office is authorized to issue necessary credit advice for this payment.
6. Utilization Certificate has been received, checked and found in order and kept in record.
7. The State Govt. of Himachal Pradesh is also required to furnish the completion




reports/certificate duly verified by the Audit as and when the work is completed.

"The expenditure is debitable under the Major Head-3601-Grants-in-aid to State Governments (Major head); 08- other transfer/Grants to State (Sub-Major Head); 08.108 - Grants from Central Road and Infrastructure Fund (Minor Head); 01.00.35 - Grants for Creation of Capital Assets corresponding to Demand No. 86 of the Ministry of Road Transport & Highways for the year 2022-23".
