Sir,

I am directed to convey the sanction of the President to the release of funds to the tune of Rs. 4.66 Crore (Rupees Four Crore and Sixty Six Lakh only) to the State of Himachal Pradesh out of Central Road Fund for the financial year 2018-19. This is the 4<sup>th</sup> Installment being released during the year 2018-19.

2. These funds should be used for the projects approved under the Central Road Fund (State Roads) Rules, 2014 published vide GSR No.531-(E) dated 24<sup>th</sup> July, 2014.
3. For the funds to be utilized under the old on-going CRF schemes, the State Govt. of Himachal Pradesh is requested to ensure the funding pattern laid down in the relevant sanction letters of the Ministry.
4. The State Govt. of Himachal Pradesh will be required to furnish the utilization certificate in accordance with Rule 8 of the CRF Rules, 2014 in Form-I along with quarterly progress report and monthly Expenditure Statement, as per Form-II & III respectively of the Rules bid.
5. Principal CCA's Office is authorized to issue necessary credit advice for this payment.
6. Utilization Certificate has been checked, found in order and kept in record.
7. The State Govt. of Himachal Pradesh has submitted the certificate of job completion and installation of display boards on roads for CRF works.
8. The State Govt. of Himachal Pradesh is also required to furnish the completion reports/certificate duly verified by the Audit as and when the work is completed.
9. "The expenditure is debitible to the Major Head-3601 (Plan) other transfer/ Grants to State Governments; 08-Grants for State Plan Schemes (Sub-Major Head); 08.108 - Grants from Central Road Fund (Minor Head) 01; Grants for state Road; 01.00.35 - Grants for Creation of Capital Assets corresponding to Demand No. 81 of the Ministry of Road Transport & Highways for the year 2018-2019".
