Sub: Release of funds under Central Road and Infrastructure Fund (CRIF) during the 2019-2020 in the State of Himachal Pradesh.

Sir,

I am directed to convey the sanction of the President to the release of funds to the tune of Rs. 26.07 Crore (Rupees Twenty Six Crore and Seven Lakh only) to the State of Himachal Pradesh out of Central Road and Infrastructure Fund for the financial year 2019-20.

2. These funds should be used for the projects approved under the Central Road Fund (State Roads) Rules, 2014 published vide GSR No.531-(E) dated 24th July, 2014.
3. For the funds to be utilized under the old on-going CRF schemes, the State Govt. of Himachal Pradesh is requested to ensure the funding pattern laid down in the relevant sanction letters of the Ministry.
4. The State Govt. of Himachal Pradesh will be required to furnish the utilization certificate in accordance with Rule 8 of the CRF Rules, 2014 in Form-I along with quarterly progress report and monthly Expenditure Statement, as per Form-II & III respectively of the Rules bid.
5. Principal CCA's Office is authorized to issue necessary credit advice for this payment.
6. Utilization Certificate has been received, Checked and found to be in order and kept in record.
7. The State Govt. of Himachal Pradesh has submitted the certificate of job completion and installation of display boards on roads for CRIF works.
8. The State Govt. of Himachal Pradesh is also required to furnish the completion reports/certificate duly verified by the Audit as and when the work is completed.
9. "The expenditure is debatable to the Major Head-3601-Grants-in-Aid to State Government, (MH); 08-Other transfer/Grants to States (Sub-Major Head); 08.108 - Grants from Central Road and Infrastructure Fund (Minor Head) 01; Grants for



State Road; 01.00.35 - Grants for creation of Capital Assets-Grants corresponding to Demand No. 83 of the Ministry of Road Transport & Highways for the year 2019-2020.
