Sub: Release of 1st installment under Central Road & Infrastructure Fund (CRIF) during 2024-2025 to the State Himachal Pradesh.

Sir,

I am directed to convey the sanction of the President of India to the release to the tune of **Rs.55.32 Crore (Rupees Fifty five Crore thirty two Lakh only)** to the State of Himachal Pradesh out of Central Road & Infrastructure Fund (CRIF) for the financial year 2024-25. This is the 1<sup>st</sup> release during current financial year.

2. These funds should be used for the projects sanctioned under CRF as per this Ministry's guidelines issued vide OM number NH-15017/46/2018-P&M dated 31.01.2020.

3. For the funds to be utilized under the old on-going CRIF schemes, the State Govt. of Himachal Pradesh is requested to ensure the funding pattern laid down in the relevant sanction letters of the Ministry.

4. The State Govt. of Himachal Pradesh will be required to furnish the utilization Certificate in accordance with Form-I along with quarterly progress report and Expenditure report as per Form-II of the Ministry's aforesaid guidelines dated 31.01.2020.

5. Principal CCA's Office is authorized to issue necessary credit advice for this payment.

6. Utilization Certificate has been received, checked and found in order and kept in record.

7. The State Govt. of Himachal Pradesh is also required to furnish the completion Reports/certificate duly verified by the Audit as and when the work is completed.

"The expenditure is debitable under the Major Head-3601-Grants-in-aid to State Governments (Major head); 08- other transfer/Grants to State (Sub-Major Head); 08.108 -Grants from Central Road and infrastructure fund (Minor Head); 01- Grants for State Roads; 01.00.35 - Grants for Creation of Capital Assets corresponding to Demand No. 86 of the Ministry of Road Transport & Highways for the year 2024-25".

9. The accounts of the fund shall be audited by the office of the Comptroller and Auditor General of India at such intervals as may be specified by it.

10. Compliance of the provisions of OM F. No. 12(13)-B (W&A)/2020 dated 25.05.2022 issued by the Budget Division Development of Economic Ministry of Finance, has been ensured.
