Subject:- Centrally Sponsored Schemes – Routing of Funds of Central Share.


Sir,

I am directed to refer to this department letter of even number dated 30<sup>th</sup> June, 2014 and 23<sup>rd</sup> July, 2014 (copies enclosed) on the subject mentioned above. In this regard it is stated that as per existing procedure all files were required to be sent to Ways & Means Section of this department for confirmation of the central share before releasing of funds to the executing agencies.

In order to avoid the procedural delays in transmitting the funds, it has now been decided that the Administrative Departments will release the central share at their own level, after receiving the intimation of release of funds by the Government of India, in those cases where sufficient budgetary provision is already available. However, the department will intimate the details of transaction to the Ways & Means Section of this department for reconciliation of the central share.

In case of non-availability/shortfall in budgetary provision of central share, additionality from the Budget Section will be sought by the A/D.




In continuation to this department letter of even number dated 30<sup>th</sup> June, 2014, on the subject cited above I am directed to say that a meeting with some of the Administrative Secretaries and Heads of Departments (list of participants enclosed) who are receiving major amount under the Centrally Sponsored Schemes (CSS) was held on 21.7.2014 in the C.S. Committee Room, H.P. Secretariat. In the discussion the following decisions have been taken for timely release of Central Share to the executing agencies:-

1. Administrative Departments will first ascertain the likely Central allocation of funds under respective schemes and then move files / proposals to the Finance Department indicating detailed Head of Account for additional budgetary allocations during 2014-15 equivalent to 50% of the tentative allocations under those Centrally Sponsored Schemes where State Share has already been provided and the allocations made as Central Share are less than 50% of the tentative allocations for 2014-15.

2. Under those Centrally Sponsored Schemes, which do not find a mention in the revised schemes of restructured Centrally Sponsored Schemes as issued by the Planning Commission, Govt. of India, the Administrative Departments may seek clarification from the respective Central Ministries about their status and send a case for additionality to the Finance Department thereafter indicating the details pertaining the Head of Account where the additionality is required during 2014-15.
3. Regarding expenditure sanction under SCSP and TSP components of Central Share the concerned departments need not to seek the approval of the Social Justice & Empowerment Department and the Tribal Development Department for issuing the expenditure sanction for the amount received from the Government of India for Central Share under the respective CSS.

Centrally Sponsored Schemes - Routing of Funds of Central Share.

Sir,

I am directed to refer to the subject mentioned above and to say that as you are aware the Government of India has decided to restructure all the Centrally Sponsored Schemes from the financial year 2014-15, according to which funds will be released by it in the Consolidated Fund of the State and not to the concerned implementing agencies. After receipt of the amount in its Consolidated Fund, Central share is required to be transferred by the State Government to the bank account of the implementing agency within a stipulated period failing which the State will be liable to pay the interest for the period of delay.

In order to avoid any delay in the transferring of funds to the implementing agency's account, you are requested to ensure adherence of following mechanism:-

1. The Administrative Departments will keep liaison with the concerned ministry of Central Government with regard to sanction/release of fund under such CSSs.
2. As and when the amount is sanctioned/released by Central Government, the A/D will immediately get the receipt confirmed from Ways & Means Section of this department.
3. Thereafter, the A/D at their own level will release the Central share immediately if sufficient budgetary provision is there (Central share).
4. In case of non-availability/shortfall in budgetary provision of central share, additionality from the Budget Section will be sought by the A/D after checking that the central share has been received in the State account and the Budget Section will provide the additionality. Thereafter, the A/D will ensure release of the funds to the concerned implementing agency immediately.

The Administrative Department may complete the above process for timely release of funds.


