- 6. The Sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- 7. The Expenditure covered by this sanction will be met from the funds provided under Demand No.42 3601 –Grants in Aid to state Government (Major Head), 02- Grants for State Plan Scheme (Sub-Major Head) 02796 –Schedule Tribe Sub Plan (Minor Head), 35 Public Health Prevention and Control of Diseases, 3523-Flexible Pool for Communicable Diseases, GC, 352331 –Grants in Aid General for the year 2016-17.
