OFFICE MEMORANDUM

Subject: Grant of Dearness Allowance to All India Services Officers w.e.f. 01.07.2021.

In continuation of this Department's OM of even number dated the 7th March, 2020, the Governor, Himachal Pradesh, is pleased to enhance Dearness Allowance @ 14% from the existing rate of 17% to 31% with effect from 01.07.2021 in respect of All India Services Officers in terms of OM No. 1/1/2020-E-II(B) dated 20th July, 2021 & 25th October, 2021 issued by Govt. of India, Ministry of Finance, Department of Expenditure.


2. This additional Dearness Allowance shall be paid in cash with the salary of December, 2021 payable in January, 2022 and the arrears accrued from 01.07.2021 to 30.11.2021 shall be credited in the GPF Accounts of the Officers with the salary of December, 2021. The interest on this account shall accrue w.e.f. 1st January, 2022.

3. In the case of Officers who have retired in between or who have closed GPF Accounts and Officers who are governed under Contributory Pension Scheme, the arrears on account of release of additional installment of DA w.e.f. 01.07.2021 will be paid in cash with salary of December, 2021 payable in January, 2022.

4. Other terms and conditions as contained in OM of even number dated 26th August, 2009 shall continue to be applicable.

5. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
