This is regarding a proposal received from SMD seeking concurrence of IFD for release of Rs. 0.14 Crore to Nagaland, Rs. 3.66 Crore to Himachal Pradesh and Rs. 0.17 Crore to Puducherry as 1st installment for the F.Y. 2023-24.

- 3. The matter was examined in IFD videNote#92 to Note#93 wherein, SMD was requested to first place on file the proposal received from these 3 States for holistic examination of the matter. It was also requested that provisional Utilization Certificate received from these States may also be flagged.
- 4. Vide Note#95, SMD had submitted the following:-
 - (i) The Govt. of Himachal Pradesh vide their letter dated <u>3.10.2023</u> has requested for release of entire amount of Gol Share.
 - (ii) The UT Admn. of Puducherry vide their letter $\underline{g-129/cor.}$) has also requested for release of GoI share.
 - (iii) The Govt. of Nagaland vide their letter dated 3.10.2023, has projected the requirement of **Rs.54.86 lakhs.** They have also indicated that the entire amount of GoI+State Share i.e. Rs.40 lakhs has already been spent by them.
- 5. On perusal of Note#85 read with Note#95 and on perusal of the proposals received from the concerned 3 States/UT along with SNA 01 and SNA 09 reports, the following emerged:-

6. With respect to the State of Himachal Pradesh, total fund of

amounting Rs. 2.75 Cr. is reflecting in their SNA account, however, as per the Bank account Statement of SNA (Page 124/cr.), it was found that Rs. 0.138 Cr in total (Rs. 64642/- as interest credited on 25.03.2023, Rs. 5,88,563/- credited as interest on 25.06.2023 and Rs. 7,26,075/- credited as interest on 25.09.2023) had accumulated as interest in their account which as per SNA -04 Report has been deposited by State of Himachal Pradesh in CFI, therefore, after deduction of the said amount actual fund available in SNA is Rs.2.62 which shows that the said State has also utilized more than 75% of the fund released earlier.

- 7. With respect to the UT of Puducherry it is submitted that fund for UT with legislature is required to be released from the Head 3602 which is not available in the present financial year, therefore, separate proposal for fund under Contingency Fund of India in Appendix- 10 for UT of Puducherry will be moved and the same will be recouped to the Contingency fund as soon as the fund would available in the appropriate head.
- 8. In respect of Nagaland, it may be seen that it has utilized its entire amount of Rs. 40 Lakhs granted in last F.Y.
- 9. The proposal was submitted for approval of AS&FA, wherein vide Note#97, US (B&F) had desired that SMD may attach SNA-04 to confirm the interest accrued, if any on Gol funds which has been remitted to CFI.
- 10. Now vide Note#103, SMD has placed SNA-04 report \$\psi-138/cor.,\$), wherein, it may be seen that the interest accrued on central share in respect of Himachal Pradesh, Nagaland and Puducherry has been deposited in the CFI by the respective State.
- 11. In light of facts mentioned above, it is proposed that we may concur to the release of Rs. 14 Lakh to Nagaland, Rs. 3.66 Crore to Himachal Pradesh and Rs. 16.75 Lakh to Puducherry as 1st installment for the F.Y. 2023-24 subject to following:-
- (a) SMD may take necessary action to ensure that adequate funds are available under the respective head from which the funds need to be released.
- (b) SMD may ensure that Extant SNA Guidelines issued by Gol are scrupulously followed while releasing funds.
- 12. Proposal at para 11 above is submitted for approval of AS&FA please.
