The undersigned is directed to convey the sanction of the President of India to the balance payment of Rs. **328608500/-** (RUPEES THIRTY TWO CRORE (S) EIGHTY SIX LAKH(S) EIGHT THOUSAND (S) FIVE HUNDRED (S) ONLY) (total amount earlier approved by Hon'ble Minister (WR,RD & GR) for release to the project HP-4 during FY:2017-18 =Rs.8750.00 lakh, out of which part amount of Rs.5463.915 lakh, has been released to State Government of HP vide sanction order No. Z-15014/16/2017-FM/4020-4040 dated 28.09.2017) to the respective State Government of Himachal Pradesh being grant under Accelerated Irrigation Benefit Programme & Flood Management **Programme (AIBP & FMP)-Flood Management Programme -Capital Assets** for the State's Annual Plan 2017-18 for the FMP Schemes as under:

The amount being released is subject to the following conditions:-

- (a) The scheme shall be completed within approved cost, within extended period and cost overrun, if any, will be borne by the State Government.
- (b) Necessary sanctions/ approvals/ compliances including codal formalities required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with project.
- (c) The State Government shall put in place a monitoring system to ensure that the project achieve its scheduled milestone and envisaged outcomes.
- (d) Provisions under GFR 2017 as also Gol directions issued from time to time in relation to Grantsin-Aid to States and utilization thereof need to be adhered to in general and those under Rule-232 in relation to Centrally Sponsored Scheme in particular. The grant is further subject to requirements of / under FMP guidelines for the 12<sup>th</sup> Plan.
- (e) The release of Rs.3286.085 lakh is towards part release of 1st installment during FY: 2017-18 and "On account" basis. As per Rule 236 (1) Audit of Accounts of GFR-2017, the accounts of above central assistance (grant-in-aid) release to Himachal Pradesh shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.

(f) The State Government shall ensure proper upkeep, maintenance and operation of the assets / facilities carried out of the project.

- (g) The grant is towards plan expenditure and should be utilized on the programme as per approved DPR, works schedule therein and in accordance with the XII Plan FMP Guidelines. Expenditure on items not included under the approved DPR or deviation from the provisions of approved FMP guidelines for XII Plan is not permissible.
- (h) Payment shall be made to the State Government immediately. Funds should be released by the State Government to the implementing agencie(s) immediately upon receipt of the same from Government of India without any delay; failing which the amount would be recovered from the State Government with interest for the period of default.
- (i) An Utilisation Certificate shall be submitted by the State for the central assistance as also the matching state share in the prescribed format in Form GFR 12-C (earlier GFR 19-A) as per rule 239 of GFR-2017 at the time of making proposal for the next release for the project or within one month from the expiry of the current financial year 2017-18 i.e. by 30.04.2018, whichever is earlier.
- (j) The Utlisation Certificate shall be issued by the Chief Engineer of the project and countersigned by the Principal Secretary / Secretary of irrigation / WR/ PW Department of the State Government. The Utilization Certificate must contain its number & date and the date of release of Central Share / State Share by the State Government to the project.
- (k) The State Government would be required to submit audited statements of expenditure incurred on the FMP component within nine (9) months of the completion of current financial year i.e. by December, 2018. The release of central assistance of the following years will not be considered if audited statement of expenditure is not furnished within stipulated period.
- (I) The quarterly physical & financial targets and progress of works shall be submitted by the State Government to the monitoring agency in accordance with XII Plan FMP Guidelines in specified performance (FMP-2 &3).
- (m) If the State Governments fails to comply with the agreed date of completion, the grant component released will be treated as loan and recovered as per usual terms of recovery of the Central Loan.
- (n) Concurrent / Performance evaluation for the project in accordance with Para 9.1 and 9.2 of XII Plan FMP Guidelines is mandatory.
- (o) The concurrence is subjected to Monthly Expenditure Plan (MEP) and Quarterly Expenditure Plan (QEP) ceilings and relaxation involved, if any, shall be taken care by Office of Controller of Accounts / Budget Division.
- (p) The expenditure is also subject to posting of expenditure on PFMS and directions of Ministry of Finance in relation to PFMS and Treasury Single Accounts (TSA) and guidelines in relation to Autonomous bodies for EAP module, as may be applicable.
- (q) The funds to the State Government of Himachal Pradesh shall be released through Central Account Section (CAS), Nagpur in accordance with the latest instructions of the Ministry of Finance on the subject.
- 3. Payment is adjustable in the account of Central Government in the books under the sub-head indicated as under:
