The State Govt. is requested to furnish the Utilization Certificates (UCs) in the prescribed proforma new **GFR-12-C** to this Department at the end of the financial year. It is also requested to submit Quarterly Progress Reports for both physical and financial achievements (indicating Central share and matching State share separately) regularly.

The accounts of the State Govt. in respect of Food and Nutrition Security shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the State Govt./institution is called upon to do so.

9. The State Govt. is also requested to ensure registration of all the implementing agencies till last levels and use of Public Financial Management System (PFMS) for flow of funds so that effective monitoring of funds utilization can be done as per Rule 232 (v) of GFR, 2017.
