2. The above release of fund is subject to following terms and conditions:
 - a. The fund will be utilized only for the purpose it is released and no diversion of fund will be allowed in any case.
 - b. The Grantee Institutions or Organizations will submit quarterly Physical and Financial Progress Report etc. within the stipulated time or as required by Government of India.
 - c. The Grantee Institutions or Organizations will submit Utilization Certificate in prescribed format as per (GFR-12C) on PFMS only [Rule 86(6)].
 - d. The above release of fund is subject to terms and conditions and Guidelines set forth by this Department.

The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning grants-in-aid.
8. This Sanction has been noted at Sl.No . 18 of the Control Register of Grants for 2023-24 as per requirement of GFR 2017.
9. This sanction is valid till 31st August, 2023 based on the exemption given in DoE O.M dated 09.06.2023.
10. This sanction issues in exercise of the powers conferred on this Department in consultation with the Internal Finance Branch vide their Dy.No.88939-FTS/AS&FA, dated 10.08.2023.
