With reference to Director of Agriculture, Govt. of Himachal Pradesh letter No. Agr.H(II-Tech)F(7)2/2014-V dated 17.04.2023, I am directed to convey the sanction of the Competent Authority for Rs.1,91,96,200 and release of Rs.15,35,700/- (Rupees Fifteen Lakh Thirty Five Thousand Seven Hundred only) as second installment in favour of Government of Himachal Pradesh (exclusively for ST Farmers) for implementation of Seed Village Program under 'Food and Nutrition Security' for the Financial Year 2023-24.

2. The above release of fund is subject to following terms and conditions:
- The fund will be utilized only for the purpose it is released (i.e. exclusively for ST Farmers) and no diversion of fund will be allowed in any case.
 - The Grantee Institutions or Organizations will submit quarterly Physical and Financial Progress Report etc. within the stipulated time or as required by Government of India.
 - The Grantee Institutions or Organizations will submit Utilization Certificate in prescribed format as per (GFR-12C) on PFMS only [Rule 86(6)].
 - The above release of fund is subject to terms and conditions and Guidelines set forth by this Department.

5. Necessary Utilization Certificate has been uploaded on PFMS.
6. The nature of grants is recurring.
7. Rule 236(1)-Audit of Accounts. The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning grants-in-aid.

9. This sanction issues in exercise of the powers conferred on this Department in consultation with the Internal Finance Branch vide their Dy.No.88939-FTS/AS&FA #244, dated 10.08.2023.
