Sir,

In supersession of this office order of, even no. dated 08.05.2020, I am directed to convey the sanction of the President to grant of loan of Rs.75,00,000 (Seventy Five lakhs only) to the States Governments as indicated below, to enable these State Governments to meet the expenditure incurred by them in connection with the granting of House Building Advance to the Member of All India Services during previous financial years. Further, an outstanding amount of Rs 34.60 lakhs to be reimbursed to State of Sikkim at later stage. The remaining Budget of Rs.90,00,000 (i.e. Rs.1,65,00,000- Rs 75,00,000) is kept on hold in view of demand from other States may also arise in due course.

2. The loans carry an interest rate as revised from time to time and is repayable in ten equal instalments (1/10<sup>th</sup> of the Capital plus the interest on balance), which fall due every year on the last date of disbursement of loan.
