Subject: Release of partial amount of 1st Installment of Grant-in-aid to State Government of Himachal Pradesh under Centrally Sponsored Schemes *Setting up of State Institutions of paramedical sciences in States and setting up of college of paramedical education*

Sir,

I am directed to convey the sanction of Competent Authority to the release of partial amount of 1st Installment towards Grant-in-aid totaling to Rs. 2,12,00,000 (Rupees Two Crore Twelve Lakhs only) to the following State Government under the Centrally Sponsored Scheme for *Setting up of State Institutions of paramedical sciences in States and setting up of college of paramedical education*:

2. The expenditure is debitable to Demand No. **042**-Ministry of Health & FW under Major Head **3601**-Grants in aid to State Governments, **06101**- Central Assistance/Share (Minor Head), **20**- Human Resource for Health & Medical Education, **2006**- Setting up of State Institutions of paramedical sciences in States and Setting up of Colleges of Paramedical Education: **200635**- Grants for creation of capital assets during the financial year 2018-19.

3. The grant-in-aid is subject to the following terms and conditions: -

(i) The grant-in-aid should be utilized for the purpose for which it has been sanctioned.

(ii) The grant-in-aid is subject to the conditions and principles laid down in Rule, 228 to 245 of the General Financial Rules, 2017 and instructions there under, modified from time to time as well as other specific conditions that may be circulated from time to time.

(iii) The accounts of the grantee institution/organization shall be open to inspection by the sanctioning authority and audit both by the Controller and Auditor General of India under the provisions of CAG (DPC) Act, 1971 and

internal audit by Chief Controller of Accounts of the Ministry, whenever the Institution is called upon to do so.

(iv) The Grantee Institution is not authorized to divert the grants or entrust the execution of the scheme for which the grant is made for another purpose. In case of it not being in a position to execute or complete the assignment, it should forthwith refund to the Central government the entire amount of the Grant received by it.

(v) Pooling of funds under PMSSY (Pradhan Mantri Swasthya Suraksha Yojana) and the present scheme for the same project will not be permissible.

(vi) The State Government would furnish utilization certificate to the Central government of the Installments and also ensure that it has released its share in the scheme.

(vii) The State Government must ensure proper implementation of the MoU signed by it with the Central Government under the Scheme.

4. The amount shall be transferred to State Government, through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II(45/75/SC) dated 22.2.1977
