Subject: Integrated Child Development Services (ICDS) Scheme - Release of Grants-in-aid to the States during 2017-2018 towards GOI's share on **supplementary nutrition for (SC component)-1st** installment regarding.

Sir,

I am directed to convey the sanction of the President to the payment of **Rs.14,55,34,000/- (Rupees Fourteen Crore Fifty Five Lakh and Thirty Four Thousand only) as first installment of grants-in-aid during 2017-18** towards GOI's share on supplementary nutrition under the ICDS Scheme to the States as indicated below:

2. ICDS is a Centrally Sponsored Scheme in which the Centre and States/ UTs both have contributions. The above release is based on the condition that:

- i. The amount of grant will have to be utilised for all the components under the Schemes as per the schematic norms;
- ii. the States / UTs shall also be required to contribute adequate amount for implementation of the ICDS Scheme.

3. **The expenditure is debitable to the `3601"- Grants-in-aid to State Governments (Major Head) in Demand No. 99, Ministry of Women & Child Development under sub-head; 06-Centrally Sponsored Schemes (Sub Major Head), 06.789- Scheduled Castes Component, 42 - Anganwadi Services, 42.00.31-Grants-in-aid General 2017-2018 (Plan).**

4. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Human Resource Development, D, Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Human Resource Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.

5. The States shall maintain separate accounts and furnish information on actual expenditure incurred on supplementary nutrition every quarter. The information on expenditure on supplementary nutrition from 1st April to 30th June must be furnished by 15th July and for the period from 1st July to 30th September by 15th October and from the period from 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the
